Sale of Used Equipment and Vehicles

Dear Ladies and Gentlemen,

To ensure the smoothest possible handling of the sale of used equipment and vehicles, please observe the following rules:

Please note that only business entities are entitled to register on the sales platform listed in the advertisement and thus to submit valid purchase offers. We are unable to accept offers from private individuals.

1. The equipment and vehicles offered for sale are stored at the STRABAG BMTI Kft. site located at 2360 Gyál, Bem József utca 25 (GPS coordinates: 47°21'36.0"N 19°12'13.1"). In exceptional cases, deviations may occur. The exact storage location is indicated on the item or vehicle data sheet.
2. Viewing of the equipment and vehicles is possible on working days, Monday to Thursday, between 8:00 a.m. and 2:00 p.m. at the STRABAG BMTI Kft. site at 2360 Gyál, Bem József utca 25 (GPS coordinates: 47°21'36.0"N 19°12'13.1"). If another location is specified in the advertisement, please contact the designated contact person there to arrange a viewing appointment. If you purchase the equipment, collection from the given site can only take place on working days (Monday to Thursday) between 8:00 a.m. and 2:00 p.m., after prior appointment.
3. Purchase offers for equipment and/or vehicles remain valid for at least 30 days from the date of submission and do not require immediate confirmation from the seller to be valid.
4. Upon sale of equipment and/or vehicles, the purchase contract is automatically concluded upon acceptance by STRABAG BMTI Kft. If the vehicle to be purchased, as stated in the advertisement, qualifies as a vehicle according to Annex 1, Section II, point a) of the Hungarian Road Traffic Regulations (1/1975 (II.5.) KPM-BM joint decree), a separate written purchase contract will also be concluded.
5. Offers cannot be submitted by phone or email and may only be made via the sales platform. By submitting an offer, you confirm your interest in purchasing a piece of equipment or vehicle at a specific price. Once we receive your offer and find it acceptable, we will contact you for further coordination. The seller reserves the right to extend the auction period if the minimum price is not reached or if no satisfactory offer is received. Multiple extensions are possible.
6. Please note that STRABAG BMTI Kft. assumes no warranty or liability for defects for products advertised on the sales platform. Before acceptance of your purchase offer, the buyer will be informed of any known defects or deficiencies in the equipment or vehicle. By submitting your purchase offer, you expressly acknowledge these defects or deficiencies and waive any claims or demands against the seller arising from them.

7. Please note that the advertised equipment and vehicles are considered used items. The buyer is obliged to inspect the purchased equipment or vehicle at the time of transfer of possession.
8. The risk of damage passes to the buyer upon conclusion of the purchase contract, regardless of whether the transfer of possession occurs at a later date. The seller retains ownership until full payment of the purchase price.

Characteristics of open auctions:

- Automatic update: The page automatically refreshes during the auction.
- Automatic extension: If a bid is placed within one minute before the auction ends, the auction is automatically extended by 2 minutes each time – until no further bids are received within the last minute.

9. General information:

In case of agreement, a purchase contract will be concluded in accordance with point 4. The purchased equipment or vehicle can be collected from the location specified in the advertisement after proof of payment and by prior appointment during working hours. Prices do not include loading or transport costs and do not cover disassembly necessary for transport. Please coordinate any special requests regarding loading or other relevant matters with the respective contact person.

10. The purchased equipment must be collected promptly after payment and signing the purchase contract, but no later than seven working days after notification. From the tenth working day onwards, a storage fee of EUR 3.0/m²/day will be charged. A longer collection deadline requires a separate agreement.
